Actual Results

Purchased seed and plant materials for 2023.

Purchased plant plugs for City of Blaine, City of Fridley, Anoka Parks Bunker Park, Anoka Parks Coon Lake Park turf to pollinator planting projects.

CCMI helped plant Anoka Parks sites. Volunteers helped plant Blaine and Fridley park sites.

Paid postage for volunteer seed collector = \$8.50.

Created custom seed mixes. Ordered plant plugs. Anoka Parks and Red Rock Fire conducted most of the 2024 Rx burns. Seeded sites following burn. Planning for other sites to have additional site prep/spot weeding and then they will be seeded and planted in fall 2024.

Q3 2024. ACD staff controlled weeds via spot mowing and spot herbicide at Bunker Hills Regaionl Park, Coon Lake, Commons Park and Laddlie Lake turf to pollinator planting sites. Developed planting plans and purchased plants for Bunker Hills Gatehouse North and South, Commons Park, Laddie Lake, Fridley Commons, Coon Lake replanting. Created outreach materials and coordinated with project partners to engage volunteers at Laddie Lake. Plantings and watering at Bunker Gatehouse North and South and Coon Lake. Weed control at Bunker Pasture Unit.

Q4 2024. Volunteer planting event at Laddie Lake. Additional planting to fill in gaps after weed control at Fridley Commons Park and Coon Lake completed by ACD staff.

ACD and Anoka County Parks staff watered new plantings. Received seed, split seed orders for sites and hand broadcasted seed in bare spots at Bunker Gatehouses, Bunker Pasture Unit, Rice Creek Chain of Lakes Wargo Unit and Laddie Lake. Continued to add assessment and management activities to site Conservation Plans.

A total of 63 acres of prairie have been enhanced with weed control, prescribed burns and seeding.

Turf to pollinator plantings occurred in 6 areas.

Actual Results

Surveyed sites, mapped sites, site prep, drafted seed and plant orders, created custom seed mixes, drafted Conservation Plans

Unfortunately, no Rx burns occurred in spring 2023 at Anoka Parks prairie units as originally scheduled.

Seed mixes are purchased and stored in cold dry storage for fall 2023 and spring 2024 burns.

Plant plugs planted at one prairie unit.

All turf to pollinator planting sites were prepped and seeded; one planted, remainder will be planted in fall 2023.

Conservation Plans drafted, many on elink attachments.

Additional site prep in prairie units.

Local seed collection.

match: watered prairie violets and wetland plant plugs at Bunker Pasture unit; herbacous weed control at Anoka Parks units

match: Anoka Parks watered plant plugs, site prep mowing, establishment mowing, Anoka Parks CCMI crew helped plant plugs

match: Fridley organized volunteer planting, and planted at the event, establishment mow following spring seeding, watered sites.

Q4 2023. Anoka Pakrs coordinated and implemented prescribed burns at seven sites. The Rx burns were completed by Red Rock Fire and Anoka Park staff.

ACD staff overseeded with highly diverse seed mixes at all the Rx burn sites on bare soil.

ACD staff overseeded at Blaine Laddie Lake turf to prairie site and Bunker North and South gate turf to pollinator planting sties.

Q3 2024. Anoka Parks staff assisted with planting and watering at Bunker Hills Regional Park and Coon Lake.
